RULES OF ENTRY:	Information on eligibility, how to enter and the prize form part of these Terms and Conditions. By taking part in this Promotion, the Entrant acknowledges that he/she has read and consented to the Terms and Conditions set out below

1. Entry into this promotion is automatic, but the invoice relating to the purchase of the Eligible Products must be retained as proof of purchase for the purposes of claiming the prize.
2. The directors, management and employees (and their immediate families) of the Promoter, its related entities, printers, suppliers, providers and agencies whom are directly associated with the conduct of this promotion are ineligible to enter the promotion.
3.
